11:00-13:00 Session 1. Making best use of the value added of triangular co-operation – scaling-up multistakeholder partnerships

Triangular co-operation has multiple objectives: strategic, developmental and partnership. All partners transfer knowledge and expertise which encourages co-creation of development solutions and can lead to additional benefits. Among others, these benefits include enhanced ownership of the activity, the transfer of solutions that are cost-effective and better adapted to the needs of the beneficiary country, or the establishment of a partnership that continues beyond the duration of the activity. Those involved in implementing triangular co-operation agree that these factors are a significant value added and a key motivation for working trilaterally. Nevertheless, triangular initiatives could often be better linked to other development programmes in countries and could be planned to involve various partners in the form of multi-stakeholder partnerships.

The issue of multi-stakeholder partnerships is also linked to the question of what happens when triangular co-operation projects end:

- What are the experiences of different stakeholders in triangular co-operation?
- What preconditions need to be in place to seize the benefits of triangular co-operation?
- How can different development co-operation partners scale up successful initiatives and build synergies with other programmes?

This session will be structured in three parts:

- 1) First, a panel will introduce user stories on how contributions of different types of stakeholders can be leveraged and additional resources mobilised to scale up triangular co-operation.
- 2) Panellists and participants will look at how to create better synergies between triangular co-operation and other development co-operation programmes.
- 3) Having identified these synergies and against the background of the user stories, the panel will discuss with the plenary what pre-conditions need to be met to scale-up multi-stakeholder partnerships.

Panel discussion on "Messages from Lisbon to Buenos Aires"

The development co-operation landscape has changed dramatically since the Buenos Aires Plan of Action was agreed in 1978. While some concepts and approaches are as valid today as they were 40 years ago, others have evolved substantially. Triangular co-operation has come of age and will feature explicitly in the United Nations second high-level conference on South-South Co-operation (BAPA +40), which was not the case at the original conference in Buenos Aires. This paves the way for all development stakeholders to shape a new agenda. The panellists will discuss messages to take from this meeting in Lisbon to Buenos Aires. The discussion will be followed by the presentation of a video of the Global Partnership Initiative (GPI) on effective triangular co-operation as a platform for participants to continue working together in preparing for BAPA + 40
